Mede met het oog op de bespreking van de CVM-rapporten over Roemenië en Bulgarije tijdens het AO RAZ op 8 september a.s., brengt de Roemeense minister van Justitie, de heer Cătălin Predoiu, op 7 september een bezoek aan Den Haag (C.V. zie bijlage).

De CVM-rapporten staan dit jaar extra in de belangstelling omdat er een verband is gelegd tussen deze rapporten en de besluitvorming over de eventuele toetreding van Roemenië en Bulgarije tot "Schengen".
