De passage uit het transcript van de briefing luidt als volgt:

“Thank you, Mr. Chairman. I’m HP Schreinemachers. I’m counselor for justice and home affairs at the Netherlands Embassy.

Just for the record, I wanted to make one comment, please, if you allow me. And that is that contrary to the impression that the panel might have given you, the Netherlands takes the fight against child sex trafficking very seriously. And we could have commented if we would have been invited to this panel. But it wasn’t until we protested not being included on this one-sided panel that you came back last Monday offering us the opportunity to ask the first question and send in a written statement. Well, since just asking a question or giving a short remark like this one doesn’t compensate for the one-sidedness, we declined to do so. We did, however, send in the letters that the minister of security and justice has sent to the Dutch Parliament, and I would refer to them. Thank you.

REP. SMITH: Could I ask you, please, if you don’t mind, was there anything you heard today that caused you to rethink that perhaps there is a very credible story here?

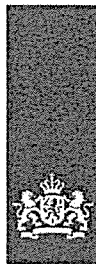
Q: I think that I’m not on the panel, so that’s not the way to address questions to me. But I – (inaudible) –

REP. SMITH: No, it’s a give-and-take. This is not a hearing. And you have the floor, and I’m asking you a very serious question.

Q: And I’m – I was in the process of giving you an answer, but I wanted to make that clear first. And that is that the information that has been given today is – has all been available. And therefore, I think it’s good that Mrs. van der Plas indicated that she’s going to take this – what is now amounting to a public trial – to the court of appeals, and I think that’s where it belongs.

Re Sexual exploitation of children and child pornography

Dear Representative Wolf,

It has come to my attention that on 31 July 2012 you wrote a joint letter to the Chair of the European Parliament's Delegation for Relations with the US, Mr. Christian Ehler, 'out of concern for the integrity of the European Union's ongoing efforts to combat the sexual exploitation of children and child pornography.' In your letter, you state that 'the Netherlands may be susceptible to becoming a "weak-link" in the chain of anti-sex trafficking efforts.'

The Netherlands highly regrets both the content and purpose of this letter. The importance of the fight against human trafficking, sexual exploitation and child abuse cannot be overstated. The Netherlands is a strong ally of the US in this fight and was recognized as such by the US State Department in its latest Trafficking in Persons report. It hailed us for our international leadership role and granted the Netherlands a 'Tier 1' rating.

As allies in this important campaign, the Netherlands values your commitment and that of the United States Congress as a whole. It was in this spirit that the Netherlands embassy in Washington responded to your request for information regarding the two matters you raise in your letter to the European Parliament. You were provided with extensive information to allow you to better understand the facts and to form an opinion on that basis. At the same time, the embassy offered to meet with you in order to exchange views on these matters and to provide further

information as appropriate. It is unfortunate that you were not available for such a meeting.

In your letter, you raise unsubstantiated doubts about the Netherlands' legal system. You suggest that neither the Dutch Public Prosecution Service nor the Dutch courts act independently. Any such implication is completely unfounded and must be dismissed entirely. Moreover, you neglect to mention the fact that the Dutch parliament has probed the issue on several occasions and has been informed by subsequent Ministers of (Security and) Justice.

It is important to correct your letter to the European Parliament on a number of points:

- *Vereniging Martijn* was banned and effectively dissolved by a district court at the request of the Public Prosecution Service. The Dutch Ministry of Justice has never taken any action to protect *Vereniging Martijn*, either by invoking the right to freedom of expression or otherwise.


- The Public Prosecution Service in the Netherlands has the full and independent authority to investigate any criminal allegation against any person within its jurisdiction. The allegations against Mr. Demmink were thoroughly investigated by the Public Prosecution Service, in full accordance with the Dutch Criminal Code and Code of Criminal Procedure. The Public Prosecution Service decided that the accusations were unfounded. Furthermore, it established that Mr. Demmink was not in Turkey in the period in question. Decisions not to prosecute were upheld by the court of appeal.

Our common cause of combating human trafficking, sexual exploitation and child abuse is not served by statements based on misperceptions, misrepresentations or accusations that have been proven to be false. Therefore, these issues do not belong on the agenda of any meeting between the US Congress and the European Parliament. The Netherlands will convey this message to Mr. Ehler.

The Netherlands is and will remain a dedicated ally in all international efforts to combat sex trafficking, child pornography and the sexual exploitation of children. We want to continue our dialogue with all parties involved in this important endeavor, including yourself. We therefore look forward to meeting with you at the earliest opportunity.

Dear Mary & Mark,

Thanks for the opportunity to give the Dutch views on the Hannaford article. In addition to the conversation, I promised to provide you with some additional information on court cases, on the Bakker Schut Stichting and on the list of websites, and give you a sense of the content of the articles you provided me with.

1. *Court cases* - After the first time the Public Prosecutors' Office (PPO) decided there was no evidence to prosecute, Baybasin/Van der Plas went to Court to try to force the PPO to prosecute. The Court ruled in 2008 that there was no credible evidence on the basis of which the PPO should take the case any further. In 2011 Baybasin/Van der Plas filed a new complaint that was again dismissed by the PPO on Feb. 2, 2012 after careful evaluation. Baybasin/Van der Plas haven't turned to the Court again to have this decision overturned (something in our system he could have done and still can do at any time it pleases them). This is proof that the statement in the article that there has been no accountability in a court of law, is false. The case has been reviewed and can still be reviewed. As I already indicated, filing the article in the Congressional Records would give it some credibility that it really does not deserve and would question the independence and professionalism of both the PPO and the court system of a close and longstanding ally.
2. *Bakker Schut Stichting* - The Bakker Schut Stichting is a foundation that has been established by Adèle van der Plas with the aim to research cases in which people's civil rights have been violated by corrupt governments. The only files on the website are those on Demmink and Baybasin.
3. *List of websites* - the unfounded story is kept alive at the predominantly conspiracy-prone websites listed.
4. *Newspaper articles*

De Telegraaf, 21 June 2008 -

De Telegraaf is the Netherlands' largest newspaper. The header of the article is "Is D. victim of a mafia plot?".

Katholiek Nieuwsblad, February 11, 2011

KN is a small weekly with predominantly catholic news items and opinions. Header: "Does the PPO want to know the truth?"

AD (Algemeen Dagblad), September 6, 2011

De AD is a "national turned regional" newspaper. The header: "Joris D. cornered"

All three articles tell basically the same story:

- Adèle van der Plas claims that criminal Baybasin, who has been sentenced to life in prison, has been set up by the Turkish government who wanted him behind bars and was able to strike a deal because it had derogatory information on Mr. Demmink.
- Ms. Van der Plas also claims that the PPO has failed to seriously investigate and that it all is a cover-up.
- The Ministry and the PPO and Mr. Demmink's lawyer claim there is no case, there are no credible witnesses, and Mr. Demmink was not in Turkey at the time of the alleged offenses, even never after 1981.
- Subsequent Ministers of Justice have strongly supported Mr. Demmink.

The articles have been published at different stages. The Telegraaf article came out after Van der Plas had collected video statements of self-declared victims. Both the PPO and the Court have since come to the conclusion that the tapes by itself do not provide credible evidence. The KN article has been published after a special committee that looks into alleged wrongful convictions, had come to the conclusion that there was no ground for reopening the Baybasin case. The AD article was published when Baybasin filed a new complaint against Mr. Demmink with the PPO.

Further, I attached a slightly modified version of the draft that I handed out last Friday.

If you have any further questions, please let me know. I trust that in case you do not immediately dismiss the request, we will have another opportunity to discuss. Please share the information with the staff of Rep. Smith as well. I would also like to get in touch with them. Could you let me know who handles this? Thank you, HP

boundaries, I will make every effort to establish whether starting points can be found for taking action against the association".

The possibilities of dealing with Vereniging Martijn under criminal or civil law have been subject of political and public debate for some time. A recurring topic of discussion was whether sufficient starting points could be found to deal with the association under criminal or civil law. Prosecution was deemed not very likely to succeed on the basis of case law of the Supreme Court. A ban under civil law is subject to very strict conditions, partly in view of the fundamental right of association. For a long time, the Public Prosecution Service was of the opinion that there were insufficient starting points for dealing with the association under criminal or under civil law. On 15 December 2011, the Public Prosecution Service submitted a request for a ban on and dissolution of Vereniging Martijn making use of civil law, on the basis of further investigation, and also pursuant to the fact that the chairman of Martijn had since been convicted of owning child pornography. On 27 June 2012, the District Court banned and dissolved Vereniging Martijn. The District Court considered the activities of the association to be contrary to public order. Vereniging Martijn has submitted an appeal.

In view of the letters to Parliament, all possibilities of criminal prosecution or having Vereniging Martijn banned on the basis of civil law have been dealt with in the public debate with Parliament. It was explained each time on what grounds the Public Prosecution Service arrived at its decisions. The Ministry did not take any action to protect Vereniging Martijn by invoking the right to freedom of expression or otherwise.

Annexes:

- Relevant passages from the judgment of the District Court pertaining to the ban on and dissolution of Vereniging Martijn

- 2.6. When assessing the request, the District Court takes into consideration that, in view of Article 8 of the Constitution and Article 11 of the European Convention on the Protection of Human Rights and Fundamental Freedoms, the right of association and freedom of expression are fundamental principles of the Dutch state. The District Court will therefore exercise restraint when applying Article 2:20 of the Dutch Civil Code and will only assume contravention of public order if the generally accepted foundations of our legal system are violated (...).
- 2.14 The District Court holds that the activities of Vereniging Martijn (...) demonstrate that Vereniging Martijn *strives* for its members to be able to have sexual contact with children and that *for this purpose* Vereniging Martijn glorifies said sexual contact and presents it as something that is or should be considered normal and acceptable. This striving constitutes a serious breach of the fundamental values within our society and it is consequently a violation of our legal order (...). In doing so, Vereniging Martijn harms the rights of children. Protecting the rights of children unmistakably constitutes one of the most essential principles of our legal order. The Dutch state should, moreover, not offer any scope for that violation from the perspective of international law.

Response to the two specific questions:

1. Statements from Ministers:

- In answers to parliamentary questions, former Minister of Justice Hirsch Ballin stated on July 5th 2007: "I conclude, on the basis of the abovementioned facts, that there is no prima facie evidence of the accuracy of old or new accusations against the aforementioned civil servant".
- In answers to parliamentary questions, former Minister of Justice Hirsch Ballin stated on July 16th 2007: "My conclusion is that no foundation for the accuracy of the allegations against the civil servants of the Ministry of Justice mentioned in the police report has been demonstrated".
- In a letter to Parliament on February 2nd 2012, Minister of Security and Justice Opstelten stated: "The Public Prosecution Service has informed me that there is no reason for initiating a criminal investigation into the Secretary General of my Ministry pursuant to the police report of the sexual abuse of a minor in Turkey in the second half of the nineties, nor on the basis of a new report made by H.B. who has been condemned to life imprisonment (...)." My conclusion is that any foundation for the accuracy of the allegations against the civil servant has not been demonstrated".

2. Martijn

Minister Opstelten of Security and Justice informed Parliament as follows with regard to the Vereniging Martijn in a letter dated 5 September 2011:

"I would state first and foremost that Vereniging Martijn is an association whose aims I reject utterly (...). Combating child abuse and child pornography has the highest priority for me (...) I think it is a good thing that the Public Prosecution Service continues to examine closely and actively whether the association operates within the boundaries of the law. I would note in this connection that the freedom of association and assembly is a fundamental principle of a democracy based on the rule of law. Those fundamental rights also apply with respect to groups whose ideas I wish to have nothing to do with. However, these fundamental rights are not absolute and legal restriction is possible. Within those

2.16. The above matters, considered in their mutual relationship, lead to the following. The District Court holds first and foremost that propagating opinions that are undesirable in the eyes of many people does not constitute a ground for banning and dissolving Vereniging Martijn. The right of association and the right to freedom of speech apply for everyone and consequently also for those who have sexual feelings for children. This does not alter the fact, however, that the activities of Vereniging Martijn constitute a violation of the generally accepted foundations of our legal system and that these activities are contrary to public order. The District Court will ban and dissolve Vereniging Martijn on that ground.

I have had a chance to go through the statement from the Prosecutor's office, and had a follow up question:

My translation of the following sentence leads to the question of whether the follow up research is being done on missions and passports, or has it been concluded? If I remember correctly, you indicated that the research had been concluded. It is probably a poor translation issue on this end. But if further research is coming, I would be most happy to receive it.

WASHINGTON, Aug. 6, 2012 /PRNewswire via COMTEX/ -- REQUESTING THAT THE EUROPEAN UNION INVESTIGATE Shared Hope International and The Rebecca Project are pleased to announce that the U.S. Congress has taken action regarding the lack of action of the European Union in investigating child sex trafficking in the pedophilia charges against Joris Demmink, a high ranking government official in The Netherlands, and requested this matter be broached at the next Interparliamentary meeting.

Congressmen Pitts (R-PA), Wolfe (R-VA), and Smith (R-NJ) state in a letter just delivered to EU Chairman Christian Ehler: "We write to you out of concern for the integrity of the European Union's ongoing efforts to combat the sexual exploitation of children and child pornography. As combating these crimes remains a top EU priority, we are alarmed by recent assertions of the Dutch Ministry of Security and Justice relating to the prosecution of the group 'Martijn' and allegations of child sex abuse against the ministry's secretary-general, Mr. Joris Demmink.

As you may be aware, Mr. Joris Demmink has been accused of child rape. It is asserted that Mr. Demmink traveled to Turkey in the late 1990's to carry out the abuse and rape of numerous victims, and furthermore, it has been asserted that Mr. Demmink used the power of his position to obstruct efforts to file complaints against him, and used investigations as a way to deter his accusers.

Mr. Demmink is accused of what could be considered child sex tourism, a form of human trafficking. Given the nature of the allegations against Mr. Demmink and his influence within the Ministry of Security and Justice, we are concerned that the Ministry may not be able to properly execute The Netherlands' responsibilities under the EU Decision 2004/68/JHA, the Framework Decision on combating the sexual exploitation of children... " Shared Hope International and The Rebecca Project are working to bring awareness to the global need to take seriously the threat presented to the world's children by perpetrators of child sex trafficking, and bring justice to the victims of Joris Demmink. Mr. Demmink has eluded investigation, raising grave questions about the seriousness with which governments are combating human trafficking and protecting child victims of sexual exploitation in their country and those where their citizens may travel as child sex tourists.

Dear Mr. Schreinemachers,

Thank you for the message you sent to Allison Hollabaugh, Counsel at the Helsinki commission, on Friday, and for the earlier meeting with Chairman Smith. Unfortunately that meeting did not put to rest the Chairman's concern that neither the key witnesses (Turkish policeman and the former Chief of Police of Istanbul) nor the primary victims (other than one victim) were interviewed as part of the Dutch investigations into the very serious allegations against Mr. Demmink. Consequently the Chairman has decided to move forward with the announced briefing.

Regarding your other views about the briefing, if the ambassador or government of the Netherlands would like to submit a statement for the briefing record, I would be happy to have that added to the written record. I'll attach the commission's guidelines for submissions. In addition, it is the commission's practice at briefings to take questions from the audience; that is, the briefing opens with statements from panelists, then moves into questions from commissioners and commission staff, then to questions from the audience, at which time embassy officials are free to pose questions to the panelists. We will give the ambassador or another embassy official the opportunity to ask the first question, and will extend him or her enough time to preface a question with a statement.

I hope this helps to address your concerns.

XXVII. COMMISSION HEARING PROCEDURES

Criteria for Materials to be Submitted for the Record

Materials meeting the following criteria will be considered for inclusion in the official record of Commission hearings and briefings. Submissions that do not meet these criteria may be excluded:

- Submissions may be no longer than 5 pages in length.
- They must be in English.
- They must be submitted electronically.
- They must be received by close-of-business (5:30 p.m., EST), two days after the hearing or briefing.
- They must address the specific subject of the briefing.
- They must not include personal invective or insult.
- If submitted after the time for the opening of the hearing or briefing, the text must read as though submitted by the opening of the hearing or briefing (i.e., it may not contain references to discussions at the hearing or briefing, or events subsequent to the beginning of the hearing or briefing.)

Allison,

Please allow me to share a personal observation (and thus not a formal Dutch position) that I will relay to the Ministry of Foreign Affairs. Last week the Ambassador and Congressman Smith discussed the allegations against Mr. Demmink. As the Ambassador indicated: the Dutch Public Prosecutor has on several occasions found these allegations to be without merit. These findings have been weighed and subsequently supported by Ministers of Justice of different political parties. Subsequent Parliaments of varying political majorities have seen no reason to doubt the work of the Public Prosecutor and to probe further. Recently, an Advocate General to our Supreme Court has extensively argued why he has no reason to believe in the conspiracy theory of a cover up. Further, the Ambassador explained that the complainants have the opportunity to take this to the Appeals Court, but have not done so in the past seven months. Despite all that, you have decided to hold this particular one-sided briefing.

Moreover, when we the Ambassador and the Congressman spoke, the briefing must have been in the making. I find it disheartening that the Congressman did not mention it and, again, did not give the

Ambassador the courtesy of expressing the Dutch opinion before the invitation had been sent out and posted online. Again, the Dutch government has not been invited to express its side of the story during the briefing.

In my opinion, the one-sidedness with which this case is being handled, goes against the very principles the Helsinki Committee assures the public that they defend. I will advise the Ambassador and the Ministry accordingly.

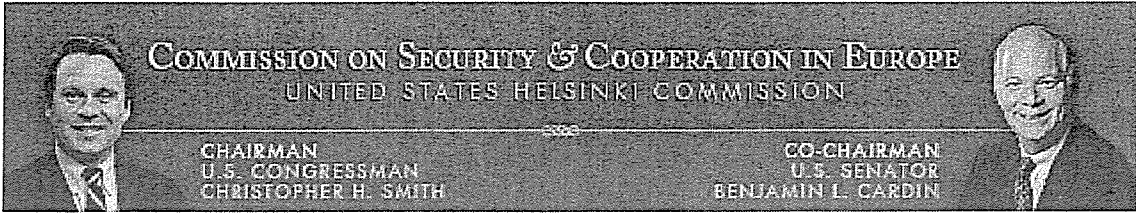

The sex trafficking and abuse of children is a crime that destroys the lives of the victims as well as the social fabric of society. The traffickers and abusers rely on their ability to frighten a child into silence or the reluctance of adults to listen when children speak. It is imperative that the justice system be ready to listen to allegations and to thoroughly investigate them.

The Helsinki Commission, in conjunction with the Victims' Rights Caucus, will hold a briefing on how justice systems can most effectively respond to domestic and international allegations of child trafficking. The briefing will include a current case study in the Netherlands, where a government official has been accused of domestic and international child sex trafficking. Dutch authorities conducted a preliminary investigation, but many have found it grossly unsatisfactory as Dutch authorities interviewed only one of three victims and none of the available witnesses or facilitators of the alleged crime was interviewed.
